AN ORDINANCE APPROPRIATING <u>\$9,000</u> <u>\$15,500</u> <u>\$17,500</u> FROM DISTRICT NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: <u>\$4,500</u> from District 12; <u>\$2,000</u> from District 24; <u>\$1,500</u> from District 14; <u>\$1,000</u> each from Districts 15, 13, <u>20, 16</u>; <u>\$500</u> each from Districts 9, 22, <u>21, 1, 3, 2, 10, 6, 7, 17, 25</u>; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO HARBOR HOUSE OF LOUISVILLE, INC., FOR PROGRAM EXPENSES ASSOCIATED WITH THE KEN-DUCKY DERBY (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of <u>\$9,000</u> <u>\$15,500</u> <u>\$17,500</u> is hereby appropriated from the balance of District

Neighborhood Development Funds in the following manner: \$4,500 from District 12; <u>\$2,000 from</u>

<u>District 24;</u> \$1,500 from District 14; \$1,000 each from Districts 15, 13, <u>20, 16;</u> \$500 each from Districts 9, 22, <u>21, 1, 3, 2, 10, 6, 7, 17, 25;</u> through the Office of Management and Budget, to Harbor House of Louisville, Inc., for program expenses associated with the Ken-Ducky Derby.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
