FOR WHEELCHAIR TO ACCESSIBLE RAMPS, STAIR RAILINGS AND GRAB BARS, BY ADDING \$2,400 FROM DISTRICT 25 NEIGHBORHOOD DEVELOPMENT FUNDS FOR **NEW** TOTAL **APPROPRIATION OF \$61,400.**

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$2,400 is hereby appropriated from District 25 Neighborhood Development Funds, by amending Ordinance No. 160, Series 2015, which appropriated a total of \$59,000 in Neighborhood Development Funds, through the Office of Management and Budget, to the Center for Accessible Living, Inc. for materials to construct wheelchair accessible ramps, stair railings and grab bars, for a new total appropriation of \$61,400.
