**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$10,500~~ \$11,500 \$13,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 15; \$1,000 each from Districts 4, 12, 13, 6; \$500 each from Districts 21, 24, 2, 25, 5, 7, 14; \$250 each from Districts 8, 20; to Metro

Parks Department to fund the 2015 Louisville Jack O'Lantern Spectacular held in Iroquois Park.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
