BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$7,250 is hereby appropriated from Neighborhood Development Funds in the following manner: \$500 each from Districts 18, 14, 13, 5, 24, 17, 16, 20, 22, 3, 2; \$250 each from Districts 7, 23, 8, 12, 21, 25, 15; through the Office of Management and Budget, to the Start of the Heart Foundation, Inc. for training equipment and program materials for a hands-on CPR training program.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
