**Be it ordained by the Legislative Council of the Louisville/Jefferson County Metro Government (The Council) As Follows:**

**SECTION I:** Part I. H. Public Works & Assets of Ordinance 104, Series 2015 is hereby amended as follows:

Public Works and Assets for bituminous resurfacing of North English Station Road as listed in Section I of this Ordinance. This Ordinance fulfills the Resolution requirement from the Commonwealth of Kentucky Transportation Cabinet by further recognizing the authority granted by KRS 67C.105(5)(h) for the Mayor to enter into this agreement.
