WHEREAS, the Metro Government wishes to enter into this agreement through Develop Louisville's Planning and Design division.

BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept \$531,791 of supplemental Federal Congestion Mitigation and Air Quality funding for the continuation of the Seneca Loop Bicycle and Pedestrian project.
