BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: Part I., A. Mayor's Office/Louisville Metro Council, 2. Louisville Metro Council, of Ordinance No. 103, Series 2015, is hereby amended as follows:

- 2. LOUISVILLE METRO COUNCIL
 - a. General Operations General Fund <u>5,269,000</u> <u>5,289,000</u>
 - b. Neighborhood Development Fund General Fund <u>2,724,900</u> <u>2,704,900</u>

SECTION II: The Council has determined the funds requested in this ordinance will be expended for a public purpose.

SECTION III: This Ordinance shall take effect upon its passage and approval.
