## BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept \$390,650 of funding for preliminary design plans for the extension of River Road West from 7<sup>th</sup> Street to Northwestern Parkway.

**SECTION II:** This Resolution shall take effect upon its passage and approval.
