BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$7,800 is hereby appropriated from Neighborhood Development Funds in the following manner: \$7,000 from District 22; \$500 from District 20; \$200 from District 6; \$100 from District 19; through the Office of Management and Budget, to C.H.O.I.C.E., Inc., for a "Dare to Dream" sports leadership and mentoring program.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.
