**Be it ordained by the Legislative Council of the Louisville/Jefferson County Metro Government (The Council) As Follows:**

**SECTION I:** Part I., APPROPRIATIONS/AUTHORIZATIONS, of Ordinance No. 103, Series 2015,

is hereby amended as follows:
