**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,000.01~~ \$24,500 \$29,500 is hereby appropriated from Neighborhood Development Funds in the following manner: ~~\$5,000.01~~ \$10,000 each from Districts 14 and 4; \$1,000 each from Districts 9, 12, 13, 15, 24, 25; \$500 each from Districts 5, 8, 16 6, 7, 17, \$250 each from Districts 2, 21; through the Office of Management and Budget, to the Louisville Asset Building Coalition, Inc. for programming expenses associated with implementing the Volunteer Income Tax Assistance Program (VITA).

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
