Now therefore be it ordained by the Legislative Council of the Louisville/Jefferson County Metro Government as follows:

**Section I:** That the zoning of the property located at 7300 S. Hurstbourne Parkway and Tax Block 636, Lot 155 Containing a total of 2437.840 acres (24.40 acres changed from R-4 to PEC & 13.44 acres changed from R-4 to C-1), and being in Louisville Metro, as more particularly described in the minutes and records of the Planning Commission in Case No. 15zone1021, is hereby changed from R-4 Residential Single Family to PEC Planned Employment Center and C-1 Commercial, however, said property shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No. 15zone1021.

**Section II:** This Ordinance shall take effect upon passage and approval.
