BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$12,200~~ \$12,900 \$15,850 is hereby appropriated from Neighborhood Development Funds, in the following manner: \$5,000 from District 12; \$2,000 from District 24; \$1,500 from District 14; \$1,000 each from Districts

13, 15, 25; \$500 each from Districts 22, 3, 9, 20, 17; \$250 each from Districts 1, 2, 7, 8, 21; \$200 each from Districts 6, 5, 10; through the Office of Management and Budget, to Harbor House of Louisville, Inc., for program expenses associated with the Ken-Ducky Derby.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
