**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The total of ~~8,000~~ \$8,250 \$8,900 is hereby appropriated from Neighborhood Development Funds (NDF) in the following manner: \$2,000 from District 9; \$1,500 from District 4; \$1,200 from District 8; \$800 from District 10; \$300 each from Districts 6, 12, 13, 14, 15, 17 and 25; \$250 from Districts 5, 1; \$200 each from Districts 2, 7, 3 and 16; through the Office of Management and Budget, to Louisville Independent Business Alliance, Inc. for program and operating expenses for the Eighth Annual Buy Local Fair to be held at the Louisville Water Tower Park.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
