WHEREAS, Ordinance No. 217, Series 2015 amended LMCO Section 115 relating to Short Term Rentals; and

WHEREAS, LMCO Section 115 requires an annual registration for short term rentals; and

WHEREAS, Metro residents have for many years rented their premises during the Kentucky

Derby period without intending to create a short term rental at any other time; and

WHEREAS, a short term rental during this period is a benefit to both residents and visitors to this internationally renowned event; and

WHEREAS, Metro Council desires to enable this longstanding practice without the added
