1006 R E. Washington Street containing about 0.30 acres, and being in Louisville Metro, as more particularly

described in the minutes and records of the Planning Commission in Case No. 16zone10004, is hereby

changed from R-6 Residential Multi Family to C-2 Commercial is hereby approved, however, said property

shall be subject to the binding elements as set forth in the minutes of the Planning Commission in Case No.

16zone1004.

Section II: This Ordinance shall take effect upon passage and approval.
