BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$9,250 is hereby appropriated from District Neighborhood Development Funds as follows: \$2,000 each from Districts 15, 21; \$1,000 each from Districts 13, 6, 25, 14, 12; \$250 from District 10; through the Office of Management and Budget, to South Louisville Community Ministries, Inc. for program expenses associated with its Taste of South Louisville fund-raising event.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.
