**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$5,400 is hereby appropriated from the District 10 Neighborhood Development Funds, through the Office of Management and Budget, to the George Rogers Clark Park Neighborhood Association, Inc. for expenses associated with their annual events from July 1, 2016 through June 30, 2017.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.
