AN ORDINANCE APPROPRIATING \$20,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS, IN THE FOLLOWING MANNER: \$4,250 FROM DISTRICT 1; \$10,000 FROM DISTRICT 5; \$5,000 FROM DISTRICT 4; \$750 FROM DISTRICT 6, OF MANAGEMENT AND THROUGH THE OFFICE BUDGET. TO LOUISVILLE COMMUNITY MINISTRIES, INC., FOR COSTS ASSOCIATED THEIR EMERGENCY ASSISTANCE AND CASE MANAGEMENT PROGRAMS.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$20,000 is hereby appropriated from Neighborhood Development Funds, in the following manner: \$4,250 from District 1; \$10,000 from District 5; \$5,000 from District 4; \$750 from District 6, through the Office of Management and Budget, to the West Louisville Community Ministries, Inc., for costs associated with their Emergency Assistance and case management programs.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
