AN ORDINANCE RATIFYING AND APPROVING COLLECTIVE BARGAINING AGREEMENT (EFFECTIVE AUGUST 5, 2016 THROUGH JUNE 30, 2022) RELATING TO WAGES, **BENEFITS** AND **OTHER TERMS** AND CONDITIONS OF **EMPLOYMENT BETWEEN** LOUISVILLE/JEFFERSON COUNTY **METRO** GOVERNMENT AND NATIONAL CONFERENCE OF FIREMEN & OILERS DISTRICT OF LOCAL 32BJ/SEIU CHAPTER 320.

WHEREAS, a Collective Bargaining Agreement has been reached between Louisville/Jefferson County Metro Government and the National Conference of Firemen & Oilers District Local 32BJ/SEIU Chapter 320.

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

Section I. That the Collective Bargaining Agreement (Effective August 5, 2016 through June 30, 2022) reached between Louisville/Jefferson County Metro Government and the National Conference of Firemen & Oilers District Local 32BJ/SEIU Chapter 320 for and on behalf of bargaining unit civilian employees within the Louisville Metro Fire Department concerning wages, other items of compensation, pension, terms of employment, benefits and other matters, be and the same is hereby approved. A copy of the Collective Bargaining Agreement is attached hereto.

Section II. This Ordinance shall take effect upon its passage and approval.
