ORDINANCE NO. . SERIES 2016

AN ORDINANCE CLOSING THE EAST/WEST ALLEY BETWEEN 17TH AND 18TH STREETS CONTAINING 10,525 SQUARE FEET AND BEING IN LOUISVILLE METRO (CASE NO. 15STREETS1017).

WHEREAS, the Louisville Metro Planning Commission, as set forth in its minutes and records of Case No. 15STREETS1017, has recommended to the Legislative Council of the Louisville/Jefferson County Metro Government (the "Council") that closing the east/west alley between 17th and 18th streets containing 10,525 square feet and being In Louisville Metro be approved since the land area of the alley is being developed for the African Heritage Foundation parking lot; and

WHEREAS, the Council concurs in and adopts the findings of the Planning Commission in Case No. 15STREETS1017 and approves and accepts the recommendation of the Planning

Now therefore be it ordained by the Legislative Council of the Louisville/Jefferson County Metro Government as follows:

Section I: That the east/west alley between 17th and 18th Streets containing 10,525 square feet and being In Louisville Metro as more particularly described in the minutes and records of the Planning Commission in Case No. 15STREETS1017 and as shown on the attached plat be closed, subject to all existing easements of record and all existing utility easements or rights enjoyed by said utility companies as the result of being located in, on or over said right-of-way.

Section II: This Ordinance shall take effect upon its passage and approval.
