BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$ \$9,479 is hereby appropriated as follows: 6,979 from the District 8 and \$2,500 from

District 4 Neighborhood Development Funds, through the Office of Management and Budget, to the Highland Community

Ministries for its "Feeding the Hungry" program.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures, Section 3, as adopted by Resolution No.

290, Series 2011.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
