AN ORDINANCE APPROPRIATING \$5,200 FROM DISTRICT 8 NEIGHBORHOOD DEVELOPMENT FUNDS AS FOLLOWS: \$2,700 FROM DISTRICT 8 AND \$2,500 FROM DISTRICT 4, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE HIGHLAND COMMUNITY MINISTRIES, INC. FOR PRINTING COSTS TO RAISE AWARENESS OF PROGRAMS. (AS AMENDED)

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$5,200 is hereby appropriated from the District 8 Neighborhood Development Funds as follows: \$2,700 from District 8 and \$2,500 from District 4, through the Office of Management and Budget, to the Highland Community Ministries, Inc. for NDF request by Highland Community Ministries, Inc. for \$5,200.00 for the printing of an annual newsletter that is an outreach to the community to raise awareness of about the programs provided by the Highland Community Ministries.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures, Section 3, as adopted by Resolution No. 290, Series 2011.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
