WHEREAS, Arch Gleason served as the Kentucky Lottery Corporation President and Chief Executive Officer from September 1993 to July 2016,

WHEREAS, the Louisville Metro Council and the Board of Directors of Kentucky Lottery Corporation (the "Lottery") recognizes President & CEO Arch Gleason for his many achievements during his 23 years of service:

WHEREAS, he became the longest-tenured lottery director in the United States, serving for five governors; and

WHEREAS, he oversaw the growth of the Kentucky Lottery from \$400 million in sales per year to nearly \$1 billion; and

WHEREAS, he worked to provide more than \$2.5 billion in college scholarships and grants to 660,000 students across the Commonwealth; and

WHEREAS, he was elected to three terms as president of the World Lottery Association, travelling the globe as he led the world-wide trade organization representing the lotteries of 80 different countries over five years; and
