AN ORDINANCE **APPROPRIATING** \$1,500 \$2,250 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1.000 FROM DISTRICT \$250 EACH FROM DISTRICTS <u>2, 6, 13, 15, 21;</u> THROUGH THE OFFICE MANAGEMENT AND BUDGET, TO THE SERVICE FOR PEACE, INC. FOR PROJECT **ASSOCIATED** WITH THE GLOBAL UNITY **GAMES TOGETHER EXPENSES** TOMORROW (AS AMENDED)

SPONSORED BY: Council Members Mulvihill, Welch, and Butler, Shanklin, James, and Johnson

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$1,500 \$2,250 is hereby appropriated from the Neighborhood Development Funds in the following manner: \$1,000 from District 10; \$250 each from Districts 2, 6, 13, 15, 21; through the Office of Management and Budget, to Service for Peace for project expenses associated with the Global Unity Games - Together Tomorrow.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
