BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$1,000 \$3,800 \$5,300 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,000 from District 10; \$500 each from Districts 8, 9, 12, 13, 17, 22, 24; and \$300 each from Districts 6, 14; \$200 from District 21; the District 10 Neighborhood Development Funds, through the Office of Management and Budget, to the Louisville Nature Center, Inc. for operating and programming expenses.
