AN ORDINANCE APPROPRIATING \$1,000 FROM DISTRICT 10 NEIGHBORHOOD DEVELOPMENT FUNDS\$3,800 \$5,300 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,000 FROM DISTRICT 10; \$500 EACH FROM DISTRICTS 8, 9, 12, 13, 17, 22, 24; AND \$300 EACH FROM DISTRICTS 6, 14; \$200 FROM DISTRICT 21; , THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE LOUISVILLE NATURE CENTER, INC. FOR OPERATING AND PROGRAMMING EXPENSES. (AS AMENDED)

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$1,000 \$3,800 \$5,300 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,000 from District 10; \$500 each from Districts 8, 9, 12, 13, 17, 22, 24; and \$300 each from Districts 6, 14; \$200 from District 21; the District 10 Neighborhood Development Funds, through the Office of Management and Budget, to the Louisville Nature Center, Inc. for operating and programming expenses.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
