**AN ORDINANCE APPROPRIATING \$5,750 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,500 EACH FROM DISTRICTS 12 AND 5; \$750 FROM DISTRICT 1; AND \$500 EACH FROM DISTRICTS 4, 13, 14 AND 25; TO METRO PARKS FOR THE URBAN WILDERNESS CANOE ADVENTURE TO BE HELD OCTOBER 1<sup>ST</sup> AT RIVERVIEW PARK AND SEPTEMBER 30<sup>TH</sup> AT SHAWNEE PARK.**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$5,750 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,500 each from Districts 12, 5; \$750 from District 1; and \$500 each from Districts 4, 13, 14, 25; to Metro Parks for the Urban Wilderness Canoe Adventure to be held October 1<sup>st</sup> at Riverview Park and September 30<sup>th</sup> at Shawnee Park.

**SECTION II:** The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of

passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
