AN **ORDINANCE APPROPRIATING** \$6,100 **NEIGHBORHOOD** FROM DEVELOPMENT **FUNDS FOLLOWING** MANNER: \$4,100 IN THE FROM DISTRICT 11; AND DISTRICT THROUGH \$2,000 FROM 18: THE OFFICE MANAGEMENT AND BUDGET. TO MCMAHAN **FIRE PROTECTION** DISTRICT TO **PURCHASE TABLES** AND **CHAIRS** TO BE UTILIZED IN MCMAHAN FIRE STATION'S COMMUNITY ROOM

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$6,100 is hereby appropriated from Neighborhood Development Funds in the following manner: \$4,100 from District 11; and \$2,000 from District 18; through the Office of Management and Budget, to the McMahan Fire Protection District to purchase tables and chairs utilized in the community room at McMahan Fire Station.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures, as adopted and effective as of the

passage date.
