SECTION I: The Mayor is hereby authorized to enter into an agreement with the Commonwealth of

Kentucky Transportation Cabinet to accept additional funding of \$285,012 for the continuation of the

environmental and design phase for the Louisville Loop Ohio River Levee Trail Bicycle and

Pedestrian facilities along the Ohio River northwest from Cane Run Road to Lees Lane.
