That there is authorized the following expenditures for the operation of the Jefferson County Sheriff's Office during the calendar year 2017. The total sum of \$22,470,579 shall be allocated as follows:

Personnel	\$19,500,179
Operating	\$ 2,486,400
Capital	\$ 484,000
