Α RESOLUTION RATIFYING AND APPROVING Α COLLECTIVE BARGAINING AGREEMENT (NOVEMBER 14, 2016 TO JUNE 30, 2023) RELATING TO WAGES, HOURS, AND OTHER TERMS AND CONDITIONS OF EMPLOYMENT BETWEEN LOUISVILLE/JEFFERSON COUNTY **METRO** GOVERNMENT AND LOUISVILLE CORRECTIONS FRATERNAL ORDER OF POLICE, LODGE 77, CONCERNING NO. CERTAIN SWORN **EMPLOYEES** OF THE LOUISVILLE CORRECTIONS METRO DEPARTMENT **CLASSIFICATIONS** OF CORRECTIONS IN THE OFFICER AND CORRECTIONS SERGEANT.

WHEREAS, a Collective Bargaining Agreement has been reached between Louisville/Jefferson County Metro

Government and Louisville Corrections Fraternal Order of Police, Lodge No. 77, concerning certain sworn employees of

the Louisville Metro Corrections Department in the classifications of Corrections officer and Corrections sergeant; and

WHEREAS, pursuant to LMCO § 35.057, upon agreement between the parties to the Collective Bargaining

Agreement, the Legislative Council of the Louisville/Jefferson County Metro Government must approve a resolution for the

agreement to become final and binding;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

Section I. That the Collective Bargaining Agreement (November 14, 2016 through June 30, 2023) reached by and between Louisville/Jefferson County Metro Government and Louisville Corrections Fraternal Order of Police, Lodge No. 77, on behalf of certain sworn employees of the Louisville Metro Corrections Department in classifications of Corrections officer and Corrections sergeant concerning wages, hours, and terms and conditions of employment, be and the same is hereby approved. A copy of the Collective Bargaining Agreement is attached hereto.

Section II. This Resolution shall take effect upon its passage and approval.
