AN ORDINANCE APPROPRIATING \$7.000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$4,000 FROM DISTRICT 22; \$2,000 FROM \$1,000 FROM DISTRICT 23; DISTRICT 24; AND THROUGH THE OFFICE MANAGEMENT AND BUDGET, TO FERN CREEK/HIGHVIEW UNITED MINISTRIES. INC. FOR CAPITAL IMPROVEMENT EXPENSES ASSOCIATED WITH REPLACING THE FLOOR OF A FOOD PANTRY

## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$7,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$4,000 from District 22; \$2,000 from District 24; and \$1,000 from District 23; through the Office of Management and Budget, to Fern Creek/Highview United Ministries, Inc. for capital improvement expenses associated with replacing the floor of a food pantry.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
