ORDINANCE NO. _____, SERIES 2016

AN ORDINANCE APPROPRIATING \$7,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$4,000 FROM DISTRICT 22; \$2,000 FROM DISTRICT 24; AND \$1,000 FROM DISTRICT 23; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO FERN CREEK/HIGHVIEW UNITED MINISTRIES, INC. FOR CAPITAL IMPROVEMENT EXPENSES ASSOCIATED WITH REPLACING THE FLOOR OF A FOOD PANTRY

SPONSORED BY: Council Members Engel, Flood, and Peden

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$7,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$4,000 from District 22; \$2,000 from District 24; and \$1,000 from District 23; through the Office of Management and Budget, to Fern Creek/Highview United Ministries, Inc. for capital improvement expenses associated with replacing the floor of a food pantry.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date

of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
