CLOSING THE AN ORDINANCE NORTHERN **TERMINUS** OF WEBSTER STREET CONTAINING 0.205 ACRES AND BEING IN LOUISVILLE METRO (CASE NO. 16STREETS1009).

WHEREAS, the Louisville Metro Planning Commission, as set forth in its minutes and records of Case No. 16STREETS1009, has recommended to the Legislative Council of the Louisville/Jefferson County Metro Government (the "Council") that the northern terminus of Webster Street containing 0.205 acres be closed since it does not serve as public access to surrounding uses; and

**WHEREAS**, the Council concurs in and adopts the findings of the Planning Commission in Case No. 16STREETS1009 and approves and accepts the recommendation of the Planning Commission as set out in said minutes and records.

NOW THEREFORE BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT AS FOLLOWS:

**Section I:** That the northern terminus of Webster Street containing 0.205 acres and being in Louisville Metro as more particularly described in the minutes and records of the Planning Commission in Case No. 16STREETS1009 and as shown on the attached street closure plat be closed, subject to all existing easements of record and all existing utility easements or rights enjoyed by said utility companies as the result of being located in, on or over said right-of-way.

Section II: This Ordinance shall take effect upon its passage and approval.
