BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: Part I., A. Mayor's Office/Louisville Metro Council, 2. Louisville Metro Council, of Ordinance No. 101, Series 2016, is hereby amended as follows:

 - a. General Operations General Fund 5,433,100 5,453,100
 - Neighborhood Development Fund General Fund 2,759,600 b. 2,739,600
