BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$17,213.37 is hereby appropriated from Neighborhood Development Funds in the following manner: \$6,713.37 from District 25; \$3,500 from District 14; \$3,000 each from Districts 12, 13; \$500 from District 15; and \$250 each from Districts 10, 21; through the Office of Management and Budget, to Prairie Village Baseball-Softball, Inc. for renovation of its T-ball Field.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval
