BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$11,500~~ \$16,500 \$19,650 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 12; \$3,500 from District 14; \$3,000 each from Districts 13, 14, 25; \$1,000 each from Districts 15, 24; \$750 from District 1; and \$500 each from Districts 3, 7, 10, 21; and \$200 each from Districts 4, 6; to Metro Parks for the 2017 Riverview Independence Festival.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
