**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of \$5,350 is hereby appropriated from District 6 Neighborhood Development Funds to Metro Parks Department for landscape maintenance to various public right-of-ways throughout District 6.
