## ORDINANCE NO. SERIES 2017

AN ORDINANCE APPROVING THE APPROPRIATION OF SIX HUNDRED FORTY THREE THOUSAND SIX HUNDRED SIXTY ONE DOLLARS AND FIVE CENTS (\$643,661.05) BUT NOT TO EXCEED SEVEN HUNDRED THOUSAND (\$700,000.00) LITIGATION **ADDRESS** BY APPROXIMATELY **FORTY-TWO** THE (42)PLAINTIFFS. FORMER AND CURRENT MEMBERS OF THE LOUISVILLE **FIRE** DEPARTMENT, FOR WAGE AND HOUR AND CONTRACTUAL CLAIMS. SPONSORED BY: COUNCILMEMBER MARIANNE BUTLER

WHEREAS, In consultation with the County Attorney and outside legal counsel, it is in the best financial interest of Louisville Metro to tender a payment of six hundred forty three thousand six hundred sixty one dollars and five cents (\$643,661.05) but not to exceed seven hundred thousand (\$700,000.00) for associated wage and hour and contractual claims of former and current members of the Louisville Fire Department;

## NOW THEREFORE BE IT ORDAINED BY THE METRO COUNCIL AS FOLLOWS:

**SECTION I:** The sum of six hundred forty three thousand six hundred sixty one dollars and

five cents (\$643,661.05) but not to exceed seven hundred thousand (\$700,000.00) is hereby appropriated from the assigned General Fund to address the litigation. The entire sum of up to seven hundred thousand dollars (\$700,000.00) is hereby authorized to be transferred to the Risk Management Fund.

**SECTION II:** This Ordinance shall take effect upon its passage and approval.
