A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT \$376,100 OF FUNDING FROM THE KENTUCKY CABINET FOR ECONOMIC DEVELOPMENT FOR VENUE IMPROVEMENTS AND EQUIPMENT REPLACEMENTS FOR LOUISVILLE WATERFRONT PARK TO BE ADMINISTERED BY THE LOUISVILLE WATERFRONT DEVELOPMENT CORPORATION.

WHEREAS, the Metro Government wishes to enter into this agreement through the Louisville Waterfront Development Corporation.

BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The Mayor is hereby authorized to enter into an agreement with the Kentucky Cabinet for Economic Development to accept \$376,100 for energy efficient lighting upgrades, playground renovations and maintenance equipment replacements for the Louisville Waterfront Park administered by the Louisville Waterfront Development Corporation.

SECTION II: This Resolution shall take effect upon its passage and approval.
