(AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$7,500~~\$13,750~~\$16,250~~ is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 12; \$1,500 from District 25; \$1,000 each from Districts 2, 3, 13, 14, 15; and \$500

each from Districts 1, 6, 9, 10, 17, 20, 21, 22; and \$250 each from Districts 4, 5, 7; through the Office of Management and Budget, to Harbor House of Louisville, Inc., for program expenses associated with the 14<sup>th</sup> annual Ken-Ducky Derby.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
