AN ORDINANCE **APPROPRIATING** \$10.000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3,500 FROM DISTRICT 1; \$2,500 FROM DISTRICT 5; \$2,000 FROM DISTRICT 6; AND \$1,000 EACH FROM DISTRICTS 2 AND 4; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO RIVER CITY DRUM CORP CULTURAL ARTS INSTITUTE, INC. FOR EXPENSES 11TH ANNUAL ASSOCIATED WITH THE **DA'VILLE** CLASSIC DRUM SHOWCASE.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$10,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,500 from District 1; \$2,500 from District 5; \$2,000 from District 6; and \$1,000 each from Districts 2 and 4; through the Office of Management and Budget, to River City Drum Corp Cultural Arts Institute, Inc. for expenses associated with the 11th Annual Da'Ville Classic Drum Line Showcase.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
