**WHEREAS**, a Collective Bargaining Agreement has been reached between Louisville/Jefferson County Metro Government and Louisville Corrections Fraternal Order of Police, Lodge No. 77, concerning certain sworn employees of the Louisville Metro Corrections Department in the classifications of Corrections Captain and Corrections Lieutenant; and

**WHEREAS**, pursuant to LMCO § 35.057, upon agreement between the parties to the Collective Bargaining Agreement, the Legislative Council of the Louisville/Jefferson County Metro Government must approve a resolution for the agreement to become final and binding;

**NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON**

**COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**Section I.** That the Collective Bargaining Agreement (March 26, 2017 through June 30, 2023) reached by and between Louisville/Jefferson County Metro Government and Louisville Corrections Fraternal Order of Police, Lodge No. 77, on behalf of certain sworn employees of the Louisville Metro Corrections Department in classifications of Corrections Captain and Corrections Lieutenant concerning wages, hours, and terms and conditions of employment, be and the same is hereby approved. A copy of the Collective Bargaining Agreement is attached hereto.

**Section II.** This Resolution shall take effect upon its passage and approval.
