BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The Mayor is hereby authorized to accept \$4,823,960 from the Kentucky Transportation

Cabinet for a public/private partnership project which includes the purchase of 100 class 6

compressed natural gas (CNG) fueled trucks and 63 class 8 CNG fueled trucks along with the

installation of 3 fuel dispensers.
