AN ORDINANCE APPROPRIATING \$2,900 EACH FROM DISTRICTS 20 AND 22 NEIGHBORHOOD DEVELOPMENT FUNDS TO THE LOUISVILLE METRO POLICE **7**TH DEPARTMENT, DIVISION. **FOR** COSTS **ASSOCIATED** WITH THE PERFORMANCE OF THE LOUISVILLE CRASHERS AT "CRASHING THE PARKLANDS."

SPONSORED BY: COUNCIL MEMBERS BENSON, ENGEL

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$5,800 is hereby appropriated from Neighborhood Development Funds by allocating \$2,900 each from Districts 20 and 22 to the Louisville Metro Police Department, 7th Division, for costs associated with the performance of the Louisville Crashers at "Crashing the Parklands."

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
