### ORDINANCE NO. \_\_\_\_\_, SERIES 2017

AN ORDINANCE APPROPRIATING **\$14,800** \$19,400 FROM **NEIGHBORHOOD** DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$8.000 FROM DISTRICT 14; \$2,000 FROM DISTRICT 9; \$1,000 EACH FROM DISTRICTS 12, 13 AND 25; \$750 FROM DISTRICT 11; \$500 EACH FROM DISTRICTS 2, 5, 6, 7 AND 15 AND 24 ; \$300 FROM DISTRICT 21, 22 AND 26; AND \$250 EACH FROM DISTRICTS 1, 3, 4, 10, 17, 20 AND 23; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO LOUISVILLE ASSET BUILDING COALITION, INC. FOR OPERATING EXPENSES ASSOCIATED WITH COORDINATING THE VOLUNTEER INCOME TAX ASSISTANCE PROGRAM (VITA). (AS AMENDED)

#### BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$14,800 \$19,400 is hereby appropriated from Neighborhood Development Funds in the following manner: \$8,000 from District 14; \$2,000 from District 9; \$1,000 each from Districts 12, 13 and 25; \$750 from District 11; \$500 each from Districts 2, 5, 6, 7 and 15 and 24; \$300 from District 21, 22 and 26; and \$250 each from Districts 1, 3, 4, 10, <u>17, 20</u> and 23; through the Office of Management and Budget, to the Louisville Asset Building Coalition, Inc. for operating

expenses associated with coordinating the Volunteer Income Tax Assistance Program (VITA).

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for

a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
