SECTION I: The Mayor is hereby authorized to enter into an agreement with the Commonwealth of Kentucky Transportation Cabinet to accept \$150,000 of funding for the environmental and design engineering phase to construct a sidewalk along Cannons Lane between Willis Avenue and Bowman Field to connect with the Seneca Loop.
