BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$10,500~~ \$11,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 21; \$500 each from Districts 1, 2, 4, 5, 6, 9, 10, 12, 13, 15, 25, and 26; and \$250

each from Districts 3 and 14; through the Office of Management and Budget, to Kentuckiana Pride Foundation, Inc. for costs associated with the Kentuckiana Pride Parade, Concert, and Festival.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
