WHEREAS, by City of Forest Hills Municipal Order 31212-A, adopted on March 12, 2012, the City of Forest Hills

elected to participate in the Metro Partnership Program.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The amount of \$6,500 is hereby appropriated from District 18 Neighborhood Development Funds,

through the Office of Management and Budget, to the City of Forest Hills, pursuant to the Metro Partnership Program

established in LMCO 97.100, for sidewalk repair.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public

purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of
